



Service Purpose

Integrated Home Care Service (IHCS) Team is a community support services providing a wide range of care and services to the elders, the disabled, individuals and families with social needs, so as to actualise the rationale of "ageing in place" and "continuum of care".



Service Objective

To help service users to achieve and maintain an optimal level of functioning and independence, and to prevent premature and inappropriate admission to hospitals and residential care.



Target Service Users

Ordinary Cases:

- Aged 60 or above living in the community
- Disabled and the sick
- Individuals and families with social needs

Frail Cases:

- Aged 60 or above living in the community and not receiving institutional service; and
- Assessed and recommended for Community Care Services or Residential Care Services under the Standardised Care Need Assessment Mechanism for Elderly Services.
- Carers of the service users of the frail cases of IHCS

Home Care and Support Services for Eldery Persons with Mild Impairment Cases(HSMI):

- Aged 60 or above living in the community and not receiving institutional care service;
- Waitlisting for IHCS(OC); and
- Assessed to be at the state of mild impairment or above under a designated assessment tool; or
- Assessed and recommended for "Home Support Services" under Standardised Care Need Assessment Mechanism for Elderly Services, and referred to the respective IHCS team by social worker.

The scope and frequency of services will be designed by our service team according to the needs of individual service users.

Besides the services mentioned above, we also organise volunteer visits, social activities and make service referrals so as to enhance service users' social networks and enable them to have positive outlook of life in the community.



Service users are required to make co-payment with amounts determined on the basis of their household income, and may be revised annually.



Application for Service

Ordinary and HSMI cases:

Applicants can approach respective Integrated Family Service Centres/Integrated Services Centres, Medical Social Service Units, District Elderly Community Centres, Neighbourhood Elderly Centres or Social Centres for the Elderly for referrals or Integrated Home Care Services Teams (IHCSTs) for direct application and arrangement of assessment.

Frail cases:

Applicants can approach respective Integrated Family Service Centres/Integrated Services Centres, Medical Social Service Units, District Elderly Community Centres, Neighbourhood Elderly Centres or Social Centres for the Elderly for referrals and arrangement of Standardised Care Need Assessment Mechainism for Elderly Services. Termination of Service

Self-withdrawal:

Service users can inform our social workers for termination of service.

Discharge arrangement: Ordinary and HSMI cases:

• Services will be terminated according to the result of service assessment.

Frail cases:

• Services will be terminated for the following conditions:

Self-withdrawal, suspension of service over 30 days (such as long hospitalisation or departure etc.), improved self-care ability, other support network available, institutionalisation, deceased.
